Application

 This product is a cordless handpiece used primarily for root canal enlargement.

Contraindication

 It is prohibited to use in them such as patients with hemophilia or heart disease. Patients and doctors with pacemakers. Pregnant women and young children need to use caution.

User

This device is only allowed to be used in hospital environments, clinics
or dental offices by qualified dentists and other legally licensed
professionals. Do not use this device for anything other than its
specified dental purpose.

Requirement for the file

 The Dental Electrical Motor connects with the file which must meet the requirements of the type 1 in ISO 1797–1.

Prohibition

- The product cannot be used to expand the grossly twisted root canal;
- The product cannot be used for treatment other than implantation or other root canal therapy;
- Hemophilia patients, patients with pacemakers and doctors are prohibited;
- Patients with heart disease, pregnant women and young children are cautious.



- If there's liquid leakage on the battery, or handpiece deform or fade, immediately stop using and contact with your dealer.

- Keep the charging interface away from something conductive such as copper scrap.
- · Please use original charger to charge the battery.
- When inserting the motor handpiece into the charger, check that the buzzer sounds and the LED indicate charging (animation for remaining battery capacity). Unless charging is indicated, this function is not performed and burns may result by heat generation or liquid leakage may result, therefore, stop use and contact your dealer.
- The motor handpiece has an electronic circuit (TORQUE LIMITER Function) to prevent files from breaking; however, files may still break due to metal fatigue if the torque is conditioned to be higher. Please check the working instruction of file before use.

- "Multi position type head allows direction of contra angle to be changed easily.
- The OLED panel enhances user friendliness.
- Operates continuously for more than 2 hours (Dependent upon rated load)
- Memory for up to 10 programs. RESET bottom can be used once the error occurs.
- The auto reverse function is activated depending on the comparison between load and set torque. A wide variety of functions such as "AUTO REVERSE", "REVERSE" and "AUTO RECIPROCATING" are available.
- The motor can be turned on and off by pressing the POWER key.
- The motor softly starts. Since the rotation briefly stops before changing direction there are no vibrations and shocks during the change of directions.
- The motor will be turned into sleeping mode without any action in 10 minutes, click "power" key to wake up.
- The rotating speed and torque can be compensated perfectly by the controlling chip.
- Charging interface is designed as MICRO USB.



4. Parts and its function

Keypad and Display



POWER Key

• Long press power key to turn on or turn off the motor.



- Normal rotation operation: when the power is on
 - —Pressing this key to start the motor and pressing this key again to stop the motor.

SELECT Key

- Torque, Rotation mode and other operation setting.
 - Short press this key to set torque, rotation mode, when the machine is on.
 - ◆ To adjust the settings in the select box by "+/-" key, the sequence are as follows "Torque—Rotation mode", the setting will be saved automatically, to press "P" to exit.
 - 2) Long press this key to start other operation setting, when the machine is on.
 - ◆ To adjust the icon of "Volume—Reciprocating—Bluetooth—Apex Locator Controls Motor—Auto Start & Stop—Factory Default—

 Left-Hander & Right-Hander—Auto Calibration" by "+/-" key, the settings will be saved automatically, and press "P" to exit.

PROGRAM Key



A program can be selected from P01–P10.

Rotation mode

Fwv: Forward, Rotation is in clockwise motion. When the load is beyond the set torque limit or reach the apical, it will be automatically reverse out, when the load is removed, it will start normal rotation again. Reverse. Rotation is in anti–clockwise motion.

• Optimum Torque Reverse, Rotation is in reciprocating mode.

Battery Symbol

The symbol indicates the battery status. The symbol will be animated when the batteries are being charged or in the refresh mode.

: About 0–10 % remains. Batteries are drained or in a remarkably low voltage. Charge the batteries.

The symbol indicating the remaining amount of the batteries indicates a voltage. When load is applied to the motor handpiece, the symbol indicating the remaining amount of the battery charge appears to become lower.





5. Operations

5.1 Charging Battery

- a) Insert the USB cord into the inlet at the back of the battery charge r. (Fig. a)
- Insert the USB cord and plug in. Make sure you have the correct model/voltage.(Fig. b)
- Turn on the power switch. At this time, check that the power lamp lights up.
- Insert the motor handpiece into the battery charge. Charging starts with the charge mark flashing on OLED (Fig. c).
- e) When the buzzer sounds and is displayed on the liquid crystal panel, charging is completed.







NOTICE

The handpiece can be charged directly by USB cord, even there is no USB cord. But please ensure the handpiece be placed in dry condition.


ACAUTION

- Please ensure the central unit and the power adapter is placed in dry and clean condition.
- Be careful of handling when placing the motor handpiece into the

- charger. Do not put handpiece into the WET or UNSAFE place.
- Never use the power adapter for anything other than this product by manufacturer.
- The charging normally takes approx. 180 minutes, but it depends on battery use conditions, battery freshness, ambient temperature, etc.
- Under the charging condition, the handpiece was not allowed to rotate.
- The completely discharged will cause the damage of the battery. The
 user should charge the battery completely once a month, or once two
 months, if the handpiece will not be used for long term.
- Do not put anything (dust, especially the metal debris) other than the handpiece on the charger. Please protect the charger carefully.
- Pull out the machine from the charge base up straightly after the battery fully charged.

5.2 Changing Contra Angle

The contra angle head can be connected with the motor handpiece at 6 adjustable head positions. Align the positioning pins of the contra angle with the positioning slots of the motor handpiece and insert the head until they click. When removing the contra angle head, pull it out axially.



⚠CAUTION

- Turn OFF the power to remove or attach the contra angle.
- Do not use the contra angle from other manufacturer
- Check that the contra angle is securely connected to the motor handpiece.

5.3 Mounting and Removing File

Insert file to contra angle, lightly turn the file until it engages with the latch mechanism. Push it inward to click File Removal, depress the push-key and pull out the file.








△ CAUTION

- When attaching and detaching the file, turn off the power beforehand.
- After the file is locked in place, lightly pull out the file to make sure the file is locked.
- Always clean the shank of the file to be installed before use. Allowing dirt to enter the chuck could cause loss of concentricity and deterioration of chucking force.
- Do not exceed the rotation speed recommended by the file manufacturers.

5.4 Preparatory Operations

- Long press POWER key to turn on the machine.
- Keep holding down the PROGRAM key until program No. suitable for file to be used is displayed.
- 3. When changing the set value of torque,



or rotation mode and other operation, press the SELECT key, select the setting item and press the " \pm / \pm " key to change.

4. Press the " +/- " key to change the speed.

5.5 Operation

Forward: Rotation is in clockwise motion.

When the load is beyond the set torque limit or reach to the apical, it will be automatically reverse out, when the load is removed, it will start normal rotation again.



Load lower than the set torque limit value

Load higher than the set torque limit value, anti-clockwise

Reverse rotation when load continues or reach to the apical, stop and return to clockwise rotation when load is removed



Reverse: Rotation is in Anti-clockwise Motion.

In the general condition, when the Endo Motor Rotate in counterclockwise motion will be claim as reverse motion. The traditional rotary files are drawing from the canal by reverse motion. Therefore, beep sound will occur when using this function.



Optimum Torque Reverse: Rotation is in Reciprocating

Load lower than the set torque limit value, clockwise and anticlockwise in turns (reciprocating) Load higher than the set torque limit value, motor will exit the root canal automatically, the exiting direction is opposite to the direction of reciprocating cutting.

NOTICE

• To set the reciprocating of rotation direction see 6.3 OTR Settings.



This function is designed specially for the RECIPROCATING ROTARY FILES, the cutting side is on the anticlockwise motion, the clockwise motion is for file to get out. If the load higher than the formatted torque (torque cannot be set), the motor will rotate clockwise continuously to let the file get out the canal. For next time use, only need to press ON/OFF key.

5.6 Rotation Mode setting

- Pressing this SELECT Key to adjust rotation mode in the select box, when the machine is on.
- Enter the Rotation Mode selection: To adjust the rotation mode of Forward (AUTO REVERSE)—REVERSE—Optimum Torque Rotation (RECEPROCATING), in sequence by "+/- "key.
- To press "P" key to quit the setting; and the settings will be saved automatically.



5.7 Speed, Torque Settings

- Start setting: When the machine is on,
 - ◆ Speed: To Press "+/-" key to adjust the speed;
- ◆ Torque: To short press "S" key, then to adjust the current torque in the select box by "+/−" key
- To press "P" key to quit the setting; and the settings will be saved automatically.



5.8 After use

When the treatment is completed, return the motor handpiece to the handpiece stand and hold down the POWER key for more than one second to turn off the power.

Auto Power Off

If the key is not operated or approximately 3 minutes passes during rotation with no-load, the power is automatically turned OFF to save energy and

prevent inn proper operation. However, if load is applied during rotation of the motor hand piece, the power is not turned OFF even during.

Last Memory

The last setting used before the power is turned OFF is memorized. The setting when the power is turned ON next is as that immediately used before the power has been turned OFF.

6. Convenient Function

6.1 Program

- The device offers 10 memory program, press "P" key to select different program from P01–P10 in sequence.
- User can set the speed, torque, rotate direction according to personal habits or the order of file.
- All the parameters will be saved automatically.

6.2 Alarm Sound Setting

- Long press "S" key, when the machine is on, the screen will display the volume icon.
- To adjust the volume by "+/-" key.
- Long press "S" key or short press "P" key to exit the setting, and all the settings will be saved automatically.



6.3 OTR Settings (Normal reciprocating mode)

Long press S key to enter the other operation mode, when the
machine is on; then keep short press until OTR icon shows on the
screen display as in the pictures., short press S key to shift the
direction of OTR, adjust the angle data by "+/-" key. The angle
difference is no less than 80 degree.

 Long press "S" key or short press "P" key to exit the setting, and all the settings will be saved automatically.



6.4 Wireless Connection Control (Optional)

We designed the product from the point of view of the doctor's use to make the operation easier. When doctors treat the molar, they need to go deep into the mouth, switch the parameter mode manually and press the button on the machine inconveniently. In order to provide more convenient operation for doctors, we also provide an optional wireless control solution.

The device has a built–in wireless transmission module, which can be connected with the wireless pedal control device that assembles the same type of wireless transmission module. The device can be controlled by the device to run, stop, forward and reverse (see the pedal instructions for the operation of connecting with the wireless pedal control device).

The device wireless transmission connection settings:

- Wireless transmission display features on and off. Long press "S" key to enter into other operation mode, short press "S" until the Bluetooth icon shows, press "+/-" to select "Bluetooth turn on" or "Bluetooth turn off".
- When Bluetooth turn on, the Bluetooth icon shows, when connected, the display as follows:





CAUTION

- This wireless transmission module is one-to-one connection and does not support one-to-many connection, that is, one module can only connect with one product.
- When multiple devices automatically connected at the same time, there may be a connection error. Please connect one by one as required
- Wireless transmission function automatically save once start, factory setting this function is off.

6.5 Apex Locator Controls Motor (Optional)

In order to provide doctors with more convenient operation, using a measuring cable, the device can connect with the apex locator to realize the apex locator controls motor.

The device Operation Settings of Apex Locator Controls Motor:

- In the startup state, long press "S" to enter other setting modes, short press "S" until entering Apex Locator Controls Motor Mode "Apex Control MOTOR", and press "+/-" to select "yes" or "no".
- Long press "S" key or short press "P" key to exit the setting, and all the settings will be saved automatically.





6.6 Setting of Auto Start/Stop function

In the mode of Apex locator control motor, the rotation will auto start when file tip enters root canal (and auto stop when taken out from root canal). User can turn on/off the function according to the need by following steps.

- When the device is on, long press "S" to enter background settings.
 Short press "S" and switch to "Auto Start & Stop" as shown below.
- Press "+" to switch between YES and NO to turn ON and turn OFF the function
- Press "P" to save and quit.





6.7 Factory Default Parameters

- Long press "S" to enter other operation mode, short press"S" key until it turns into "Recovery Factory Settings". Then select "yes" by pressing "+", counting from "9" to "0", automatically shut down and complete the Factory settings.
- If the value "0" has not been reached, press the "P" key to exit the setting and give up restoring to the factory settings.







CAUTION

If this function is used, all programs will disappear and return to the originally set values. Record the present program details if required before you carry out this operation.

6.8 Left-hander & Right-hander setting

The program is applicable to Left-hander & Right-hander user.

 When the device is on, Long press "S" key to enter into other operation settings, short press "S" key until in to Left-hander & Right-hander option, adjust by "+/-" key;

 To press "P" key to quit the setting; and the settings will be saved automatically.





6.9 Auto Calibration

- Install the fully lubricated contra angle on the central unit and place it on a flat platform.
- When the device is on, Long press "S" key to enter into other operation settings, short press "S" key until in to Auto Calibration. As shown in the figure below, when "yes" is displayed (if the battery is insufficient, it will display "NO VOLT Low", it should be fully charged until it displays "yes"), press "+" to enter the automatic calibration mode;





- During the calibration process, the root canal preparation machine rotates with the decelerating machine, please do not touch it, and wait for the automatic operation to complete;
- After the calibration is completed, it will display "OK" as shown in the figure below, and it will automatically shut down and complete the automatic calibration:





 To press "P" key to quit the setting; and the settings will be saved automatically.




CAUTION:

- Before calibrating, you need to display "yes", that is, the battery must have sufficient power. It is recommended to calibrate after fully charged;
- Before calibration, be sure to clean the contra angle first, because if there are residual impurities in the process of use into the contra angle, the calibration will cause deviation.
- When calibrating, please don't bring file or any load on the contra angle.
- Do not shake the motor during calibration.

7. Maintenance

- a) Insert the spray nozzle into the contra angle head (insert to the part connect to the main unit).
- b) Insert the lubricants spray nozzle to the provided spray nozzle loop, inject the lubricants for 2-3 seconds till the outlet liquid from the head of the contra angle clean.



1. Lubricating Contra Angle

- Use qualified SPRAY to lubricate or sterilization.
- Lubricate the contra angle only.
- Apply SPRAY/SPRAY Plus after each use and/or before each calibration and autoclaving.

2. Cleaning the Motor Handpiece

Wipe it off with a cotton cloth moistened with alcohol.

3. Cleaning the Metal holder

Wipe it off with a cotton cloth moistened with alcohol.



WARNNING

Do not lubricate the motor handpiece or the Metal holder.

- Before mounting the lubricated contra angle to the motor handpiece. wipe off excess oil. Stand it on its end or lean it in the proper position for gravity draining. Mount it after excess oil has been completely drained.
- Hold the contra angle securely to prevent it from flying off by the pressure of the spray.
- Hold the SPRAY (option) upright.
- When cleaning the motor headpiece, do not use any solvent such as benzene and thinner.

8. Cleaning , Disinfection , Sterilization



CAUTION:

No part of the device was sterilized before leaving the factory.



riangle warnning:

- Do not immerse the central unit in the ultrasonic cleaner.
- Do not use liquid or spray cleaner directly, especially on the screen.
- Except the contra angle, all other parts for the device can't be sterilized by high temperature and pressure. See the following table for the cleaning methods of other parts
- Do not use any heat, radiation, formaldehyde, ethylene oxide or plasma for sterilization.



- Reprocessing procedures have only limited implications to this dental instruments. The limitation of the numbers of reprocessing procedures is therefore determined by the function / wear of the device. From the processing side there is no maximum number of allowable reprocessing. The device should no longer be reused in case of signs of material degradation.
- In case of damage the device should be reprocessed before sending back to the manufacturer for repair.

The motor handpiece uses rechargeable battery. They can be recharged more than 300 times, depending on the use conditions of the motor handpiece.






